MOON SPUN brushed with an inner foe leaving the gate, showed the way along the inside, shook clear in the two path in upper stretch, drifted out while gradually widening into the final furlong, straightened after flopping back to the her left lead at the sixteenth pole then held sway from an inner bidder. SHOOT IT TRUE saved ground off of the pace, sustained a rail rally to bid inside of the leader in the closing stages but needed more. CREED'S GOLD stalked along the inside, chased in the two path in upper stretch, got outkicked for place by an inner foe in the final furlong then held show. QUEEN MAXIMA laid off of the pace in the two path, pursued in the four to three path in upper stretch, ran on in the final furlong but was denied show and held fourth. TIME TO DAZZLE trailed in the two path, swung out to the six path entering the lane and offered a mild kick to miss fourth. HAULIN ICE brushed with an outer foe, then an inner rival, at the start, pressed four to two wide into the turn, yielded while leaning back to the four path in upper stretch then faded between horses. SHISOSPICY bobbled subtly and brushed with an outer foe at the start, stalked from the three path then weakened in the five path and between horses in upper stretch.
