7 FURLONGS. (1.20²) EIGHT BELLES S. PRESENTED BY SYSCO Grade II. Purse \$700,000 (includes \$100,000 KTDF – Kentucky TB Devt Fund) FOR FILLIES, THREE YEARS OLD. By subscription of \$300 each, which should accompany the nomination or by Supplementary Nomination of \$3,000 at time of entry. \$3,000 to pass the entry box; \$3,000 additional to start, with \$600,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Grade I stakes, allowed 2 lbs.; a Grade II or III stakes, 4 lbs. The maximum number of starters for the Eight Belles will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I–II–III), then highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, April 8, 2026 with 30 nominations.

ON TIME GIRL raced in the seven path into the lane, rallied in the upper stretch, took over three wide near the eighth pole under a long drive and edged clear in the late stages. LUV YOUR NEIGHBOR chased the pace early on, came out and bumped GOODALL entering the lane from the five path, altered back in during the upper stretch, rallied in the stretch close to the inside, made a bid near the eighth pole under a long drive but hung in the late stages. PARADISE raced back early on, swung into the six path entering the lane, rallied in the upper stretch while making a bid and finished willingly in the late stages. RIVER WIND pressed the pace early on, made a bid two wide nearing the lane, was in the five path entering the lane, made a bid from between horses near the eighth pole, drifted in and out down the lane and weakened late in the drive. GOODALL raced three wide along the turn, was in the six path entering the lane and bumped by LUV YOUR NEIGHBOR then faded down the lane. SIPPIN PRETTY was unhurried early on, raced in the seven path into the lane and improved position in the stretch run near the rail. SOLEMN VOW raced in the seven path into the lane and was empty down the lane. FRONT RUNNIN tracked the pace early on from the inside, was off the rail into the lane, altered out in the upper stretch and tired down the lane. FRENCH FRICTION set the pace early on, raced in the three path into the lane and folded up down the lane.
