5 FURLONGS. (Tapeta) (.544) ROAR S. Purse \$100,000 (includes \$25,000 FBIF – Florida Bred Incentive Fund) THREE YEAR OLDS. Free nomination by Saturday, May 2. \$625 to enter. A \$100 supplemental nomination fee may be made at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Weight: 124 lbs. Non-winner of a stakes race allowed 2 lbs.; a race other than maiden, claiming, starter or state-bred allowance race, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings. In the event this race is taken off the turf it will be run on the Tapeta course at the same distance. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (ORIGINALLY SCHEDULED FOR TURF).

UNWRITTEN RULE outpaced along the inside while travelling comfortably, commenced his bid on the turn, was angled three wide into the stretch to take aim, responded determinedly to left-handed urging, caught the pacesetter nearing the wire and was going away at the finish. MONSTER set a demanding pace, bounded clear leaving the turn but was reeled in during the final forty yards. SHIPMATE chased the pace while three wide, was urged to improve on the turn, moved four wide into the stretch and kept on without threatening the principles. GENERAL BRADLEY forwardly placed, entered the stretch three wide and lacked a rally. ZEVI'S ZONE trailed and never reached contention.
