**6 FURLONGS. ( 1.071 ) MAMIE EISENHOWER S. Purse \$75,000 ( includes \$37,500 IBF – Iowa Bred Fund ) FOR FILLIES AND MARES, THREE YEAR OLDS AND UPWARD. (Iowa Registered and Foaled) Three-Year-Olds – 120 lbs.; Older – 125 lbs. Non-winners of \$60,000 twice in 2025–2026 allowed 2 lbs.; non-winners of \$60,000 once or \$25,000 twice in 2025–2026 allowed 4 lbs.; non-winners of \$25,000 once or \$15,000 twice in 2025–2026 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$300 to pass the entry box and \$600 additional to start. With \$75,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$1,300 TO ENTER AND START. Preference will be given to those horses having accumulated the highest 2025–2026 earnings at the closing time of entries. This preference will be utilized regardless of the ownership of the horses involved. Failure to draw into the race cancels all fees. Closed Saturday, May 16, 2026 with 26 nominations.**

SAYUCAN set a pressured pace up the backstretch and around the turn, shook free at the head of the lane, widened to a clear advantage and held late. KANOJO was allowed to settle through early stages, picked up the tempo near the quarter pole, swung four wide into the drive and edged closer to the wire. DEMIDANU tracked the pace up the backstretch, launched a three wide bid at the head of the lane, sustained a steady effort and prevailed for a share. QUIET I'M NOT settled off the early pace, saved ground around the turn, hustled along the inside in upper stretch, ran on and just missed show. SIPPING FIREWATER tracked the top pair in the opening quarter, lost position around the turn, hustled along two wide down the lane and lacked closing response. JAYDENSQUEENOHARTS raced off the pace, shifted four wide in upper stretch and lacked a needed rally. DELACINA pressed the pace up the backstretch, continued in aim around the turn then gave way in the lane.
