BLUE WATERS (IRE) led the second flight through 8 of 12 fences, gained ground on the leaders before the 11th, bid to enter the stretch in front and drew clear. TIMETOSHINE (FR) raced close up to BLUE WATERS (IRE) in the second flight, moved to contention before the 11th, landed second over the final and held position to the wire. ANOINT raced out the back, gained ground after the 10th fence, bid before the final, closed quickly and rallied to pass GOLD CHARM (IRE) in the stretch. GOLD CHARM (IRE) ran midpack of the second flight, bid before the final to close ground, landing third over the final, but could not hold back ANOINT in the stretch. BELLE WISH (IRE) led through 11 fences then faded before the final. MADAKET'S ARROW trailed, showed no speed, pulled up before the final and walked off. BROKEN VOW (IRE) raced out the back and was never a factor, pulled up before the final and walked off. GOSSIPER ran in second place through 9 fences, weakened before the 10th, pulled up before the final and walked off. KOBE'S SMILE raced out the back, was never a threat, pulled up after the 10th fence and walked off. THE JOCKEY OF TIMETOSHINE (FR) CLAIMED FOUL AGAINST BLUE WATERS (IRE) FOR ALLEGED INTERFERENCE ON APPROACH TO THE FINAL FENCE. FOLLOWING THE STEWARDS' REVIEW, THE CLAIM WAS DISALLOWED AND THERE WAS NO CHANGE IN THE ORDER OF FINISH.
