RAY OF SUNSHINE broke sharp, vied inside into the far turn, fought on hard inside rivals through the final sixteenth, held sway under a very stout drive. CATCH THE HUMOR rated three wide down the backside, moved in tandem with RUNALDO leaving the quarter pole, avoided traffic four wide into the lane, dug in gamely through the final sixteenth held onto the place award. RUNALDO rated around the first turn, chased inside with CATCH THE HUMOR glued to his outside flank around the second bend, blocked by fading foe in upper start, quickly altered course re-rallied just missed the place. JUBAWITHATWIST urged along four wide mid-pack into the far turn, under strong handling steadily worked over to the rail through the lane, improved position through the final stages. SPOTAFREEONE rail trip off the vying two sum into the far turn, found a clear path five wide approaching the sixteenth marker, needed more through the final stages. XCELLENT START saved ground well off the pace, quickened stride leaving the quarter pole, six deep through the lane, went by faders late. NOCASHREFUNDS bumped at the start, vied two wide down the backside, under pressure leaving the furlong marker, faded through the final stages. PASCALINE bumped pinched at the start, rated off the pace three wide into the far turn, inside bid through the lane, came up empty late. MUAD'DIB found a clean pocket off the pace into the far turn, under pressure from the quarter pole, never threatened. DIRECT APPEAL bumped pinched back at the start, unable to recover after a rough start, never factored.
