7 FURLONGS. (1.20) CARRY BACKS. Purse \$100,000 (includes \$25,000 FBIF – Florida Bred Incentive Fund) **THREE YEAR OLDS.** Free nomination by Saturday, June 13. \$625 to enter. A \$100 supplementary nomination may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Weight: 124 lbs. Non-winners of a stakes race or two races other than maiden, claiming, starter or state-bred allowance, 2 lbs. a race other than maiden, claiming, starter or state-bred allowance, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed, then by highest career earnings.

LANGVAD showed good early foot down the backstretch to control the pace, raced off the inside, dropped down into the far turn and held gamely to be clear late under steady handling. ONE HUNDRED KINGS prompt the early leader from the outside, raced three wide near the quarter pole and kept on to finish second best. WAYNE'S LAW stalked the pace racing in hand early, three wide through the far turn, six wide into the upper stretch and kept on secure show placing. SONIC SURGE stalked the pace, ridden along from the inside through the far turn to move up but had no final winning bid. MOVE JESSE MOVE trailed early, raced two to three wide and had no response.
