6 FURLONGS. (1.071) PRAIRIE ROSE S. Purse \$50,000 (plus \$3,712IBF – Iowa Bred Fund) FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Weights: Three-Year-Olds – 120 lbs.; Older – 125 lbs. Non-winners of \$60,000 in 2025–2026 allowed 2 lbs.; non-winners of \$45,000 in 2025–2026 allowed 4 lbs.; \$30,000 in 2025–2026 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$250 to pass the entry box. \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then highest 2025–2026 earnings at the closing time of entries. Different owners will have equal draw according to weights. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Closed Saturday, May 30, 2026 with 20 nominations.

THUNDERS ROCKNROLL was well placed sitting just off the embattled top pair, crept closer late on the turn, set down three wide for the drive, responded gamely, took over the lead approaching the furlong marker and pulled away. BLUE SQUALL raced off the early pace, saved ground and took closer order late on the turn, lacked a clear path in upper stretch, got clear two wide and finished second best. DEMIDANU rated off the top trio in the early going, coaxed four wide near the quarter pole, sustained a four wide bid down the lane and gained show. SAYUCAN vied outside of GLORIETTE up the backstretch and around the turn, got collared by the winner just past upper stretch and flattened out. PEPPER MILL raced near midpack in the opening quarter then weakened around the turn and continued to tire in the drive. GLORIETTE vied inside of SAYUCAN up the backstretch and around the turn then tired in the drive. R PRETTY KITTY stumbled at the start, raced in the back and got transported via equine ambulance after the race.
