1¹/₁₆ MILES. (1401) JIM AND SANDRA RASMUSSEN S. Purse \$50,000 FOR THREE-YEAR-OLDS & UPWARD. Three-year-olds - 120 lbs.; Older - 126 lbs. Non-winners of \$60,000 at a mile or over in 2025-2026 allowed 2 lbs.; non-winners of \$45,000 at a mile or over in 2025-2026 allowed 4 lbs.; \$30,000 at a mile or over in 2025-2026 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceed fourteen (14), high weights will be preferred, then highest lifetime earnings at closing time of entries. Different owners will have equal draw according to weights. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Closed Saturday, May 30, 2026 with 26 nominations.

CORNISHMAN was forwardly placed around the first turn, prompted the pace up the backstretch, advanced to duel with WOODCOURT at the quarter pole, battled along the outside into the lane, had a head in front at the furlong marker, hustled along, cleared the lead and held firm. WOODCOURT cleared the lead with ease in opening stages and led the way around the first turn, set a pressured pace up the backstretch, took on the challenge from CORNISHMAN at the quarter pole, dueled into the stretch run, fought hard but was no match late and settled for second best. HAPPY STRIKE tracked the pace in early stages, chased the top pair three wide around the far turn, kept under a drive into the lane and dug in gamely to outnod rival for show. ZATARA rated in range two wide up the backstretch, chased the widening top pair around the far turn, hustled along two wide into upper stretch and got outdueled for show. SEIZE THE NIGHT settled inside while not too far back off the early pace, failed to respond when called upon around the far turn and retreated.
