Foaled in the State of Ohio as per requirements set forth by the Ohio State Racing Commission. Nomination fee is \$50. \$262 to enter with an additional \$488 to start, with a purse of \$75,000, of which 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, and 2% to sixth. Weights: Colts and Geldings 121 lbs. Fillies 118 lbs. Nominations Close Wednesday, June 10th, 2026. Starters to be named through the entry box Saturday, June 13th, 2026. A Trophy will be presented to the Winning Owner. This stake will not split. In the event more than fourteen (14) horses pass the entry box at the time of closing of entries, preference will be given to those horses having accumulated the highest earnings as published by Equibase. Fees to be refunded to excluded horses.

STRATEGIC PROFILE close up from the start, slipped through along the rail to gain a narrow lead at the seven sixteenths pole, drifted out bumping the runner up in upper stretch, was coxed with a right handed crop inside the fur long marker, exchanged bumps with WATER INTO WIN under a strong hand in the late stages and proved best by a narrow margin. WATER INTO WINE battled for the lead two and three wide, was bumped by the winner in upper stretch, matched strides with that one the balance of the trip, exchanged bumps in deep stretch and was denied. R U ENTICED raced four wide early and improved position late three wide. MARK MY WORDS dueled for the lead along the inside through the second turn then weakened at the top of the stretch. LEAVETHENINETY NINE was leaning on the gate, hopped the ne veered out at the start and was never involved. JOLLY MON failed to menace. RICO SUAVE stalked the pace along the inside into the second turn then gave way. COWGIRLSLUVME had no impact. GLOBAL EVENT had speed for a half, stopped on the far bend, was eased in upper stretch, walked to the wire and was walked off. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF WATER INTO WINE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLGED INTERFERENCE IN THE STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGIINAL ORDER OF FINISH.
