DRIVING MONEY settled off the pace, angled out on the turn, bid willingly, angled in near the sixteenth pole and got up for show. READS ARTFUL RUN trailed the field while never far back, went widest in the drive, closed well and didn't have enough late. HOLD MY SCOTCH set a pressured pace to the turn, responded to duel to mid stretch and stopped. This race had a timing discrepancy or malfunction, and it was re-timed using video technology to obtain the most accurate final time available.
