MATTIE GOINCOASTAL was off a step slow then moved up to prompted MAJORICAL early, shook that one off nearing the eighth pole then ducked in laving the sixteenth pole and drew clear. PURE DYNAMITE was forwardly placed early racing along the inside, steadied in tight nearing the seven-sixteenths pole then continued to save ground, angled out nearing the eighth pole to be six-wide and finished strongly. MAJORICAL vied for the lead with MATTIE GOINCOASTAL from along the inside to the stretch, could not stay with that one during the drive but held on well for third. CHAMPAGNE DELIGHT settled in the middle of the field racing three-wide and went evenly late. PARADE OF DREAMS was unhurried, rallied five-wide into the stretch and failed to seriously threaten. TWITCHING saved ground while being allowed to settle but lacked a rally.
