A Sales Stake for Alberta Bred Three, Four and Five year old horses. Horses must have passed through the C. T. H. S. (Alberta) yearling sale and made at least one start on a B track in Alberta in 2026. Nomination to this Sales Stake will be the responsibility of the owners who will pay \$150 to enter and \$150 to start. In the event that the race is over-subscribed, preference will be given to horses that made their previous start on an Alberta B track. Race is limited to 8 starters with an also eligible list of four horses.

HOLY MOSES fractious, broke slow, trailed throughout. STEWARDS INQUIRY at AFTER START was UPHELD. RIDER OBJECTION 1 versus 3 was Upheld by the STEWARDS. RIDER OBJECTION 1 versus 2 was Disallowed. RIDER OBJECTION 2 versus 3 was disallowed. STEWARDS RULING – HOLY MOSES Declared Ineligible to race and was Disqualified from any earnings.
