HARPER'S CORNER coaxed from the gate, showed the way in hand just off the inside patiently handled and settled into a comfortably rhythm through swift splits, took the inside route into upper stretch roused for the drive, drew clear under a drive to prevail. VOYAGER chased along the inside down the backstretch and then two to three wide through the turn coming under coaxing near the quarter pole and bidding into contention swinging four then three wide into upper stretch, proved no match through the final furlong for the top one while keeping on to secure the place honors well clear of the rest. PRIME AURORA coaxed from the start, chased just off the inside and then along the inside under a ride from the five-sixteenths pole, took the inside route into upper stretch, tipped out to the two path straightened away near the three-sixteenths marker and weakened while along for the show honors. POT'S RIGHT stumbled badly at the start getting away last, chased just off the inside growing detached at the tail of the field when striding a bit green down the backstretch and then along the inside through the turn coming under coaxing midway, continued along the rail into upper stretch and passed a pair of tired rivals to the finish. LUMINOUS BEAUTY chased three wide under coaxing from three furlongs out, tipped three to four wide for home, tired, and was eased through the final furlong to the finish. MADELEINE SWANN coaxed from the gate, chased four wide under encouragement with seven-sixteenths to run, angled five wide into upper stretch, faltered and was eased home to the end.
