Free to nominate with \$500 to enter and \$500 to start. Supplemental nominations of \$1500 will be accepted at time of entries which shall include all fees. \$100,000 Guaranteed to be divided per condition book stake structure payout percentages per field size. Weight: Three Year Olds –121 lbs., Older 124 lbs. Non winners of a stake at a mile or over on the Turf in 2026, 2 lbs. Non-winners of two races other than maiden, claiming, or starter at a mile or over on the Turf since February 28, 2026 allowed 4 lbs., one such race since then, 6 lbs. HIGHLY WICKED was unruly in the gate then was settled while inside in the early going, stalked the pace on the backstretch then rallied in upper stretch, powered to the front inside the furlong marker and was best in the end. BECKY'SGOTTAHAVEIT was unhurried early on the rallied on the far turn, swung out to be five wide in upper stretch for clear running room, closed willingly in late stretch to be up for the place. DIVA BEACH broke through the gate then was reloaded, set the the early pace while well handled, drew off in upper stretch but weakened in late stretch. MOONIE PIE was settled in the early going while three wide on the backstretch, made a bid four wide on the far turn to upper stretch but raced evenly in late stretch. CLEARLY CREEPS was allowed to settle while inside on the backstretch, rallied and swung out to be six wide in upper stretch but was no threat in the drive. PRECIOUS MONEY was allowed to settle then raced two wide on the far turn making a middle move then flattened out in the drive. SAVED BY GRACE was inside on the backstretch, saved ground on the far turn but was no menace. KALIL chased the early pace while two wide on the backstretch, was used up and stopped in the stretch drive.
