1 MILE. (Turf) (1.33) ELLEN'S LUCKY STAR H. Purse \$100,000 (includes \$65,000 ITDF – Indiana TB Development Fund) **FOR REGISTERED INDIANA BRED FILLIES, THREE YEARS OLD.** No nomination fee. \$150 to pass the entry box and an additional \$100 to start; with \$100,000 Guaranteed. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$625 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, purse to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. **WEIGHTS:** Tuesday, August 4, 2026. Starters to be named through the entry box by the usual time of closing. This race will be limited to twelve starters. If more than twelve horses pass the entry box, preference will be given to: (1) High Weights; (2) Highest Lifetime Earnings will be used in determining the order of preference of horses assigned equal weights (scale of weights considered). Entry fee only will be refunded if failure to draw into the race. Trophy to the winning owner. Management reserves the right to cancel this stake with less than six betting interests. Closed Wednesday, July 29, 2026 with 35 Nominations. If this race is taken off the turf, it will be run at 1 mile and 70 yards on the main track. (Rail at 36 feet).

SMOKINGHOT JUSTICE raced in the three path, bid near the half-mile pole, rallied near the three-eighths pole, was clear and was caught. KABOOM trailed in the three path, rallied in the five path near the three-eighths pole and closed for the show spot. GRAND HARBOR raced in the three path, bid near the three-eighths pole and faltered in the stretch. SWEET SUMMERTIME was unrushed early in the two path, angled to the five path near the three-eighths pole, was steadied on the far turn and improved position late. INSTILLED ZIP saved ground, bid in the four path near the three-eighths pole and faltered in the stretch. SWEET JANNAELISE raced in the three path, bid near the half-mile pole and faltered in the stretch. ELTINGE was jostled at the start, saved ground, bid in the two path near the three-eighths pole and gave way in the stretch. LADY CHAOS and SPIRITED JUSTICE saved ground and faded in the stretch. OVER AND ABOVE dueled outside of a rival and gave way in the stretch. PRAYER UNBRIDLED dueled inside before giving way near the three-eighths pole.
