6 FURLONGS. (1071) PRAIRIE MEADOWS DEBUTANTE S. Purse \$100,000 (plus \$26,595 IBF – Iowa Bred Fund) **FOR FILLIES, TWO-YEAR-OLDS.** Weight: 122 lbs. Non-winners of \$60,000 once or \$45,000 twice allowed 2 lbs.; non-winners of \$45,000 allowed 4 lbs.; maidens allowed 6 lbs. No nomination fee. \$400 to pass the entry box and \$800 additional to start. \$100,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. **SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$1,600 TO ENTER AND START.** Starters named through the entry-box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then money earned. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Nominations closed on Saturday, August 1, 2026 with 29 nominations.

WILD VEKOMA was allowed to settle up the backstretch, picked up the tempo two wide late on the backstretch, saved ground around the turn, advanced into contention, shifted a couple paths off the rail at the head of the lane, given cue, responded gamely and got up late. CRUISIN IN HARMONY tracked the clear leader in the opening quarter, swung four paths wide turning for home, came in a couple paths and was set down for the drive, finished with good response and edged closer to the wire. MY KID'S SAID NO sprinted to a clear lead out of the gate, widened under a mild ride around the turn, came three wide into the head of the lane, remained clear a furlong out then overtaken late. RORY'S RUN trailed through early stages, swung wide into the drive, lost iron during the race although unclear at what point, swung wide into the lane and passed tiring rivals. ENTICING HOTTIE raced near mid-range up the backstretch, steadied along the rail around the turn, continued to save ground then angled out at the head of the lane and offered no late run. DOWNFORCE was ridden along in pursuit of the early leader, chased three wide around the turn then gave way. FIRST COWGIRL raced off the pace and failed to gain a threatening position. THREE TWO FLU raced in contention in the opening quarter, chased two wide around the turn then faded. MINNY FOR THE MAX failed to move into contention. THE RIDER OF ENTICING HOTTIE CLAIMED FOUL AGAINST WILD VEKOMA FOR INTERFERENCE AROUND THE TURN, AFTER REVIEW NO ACTION WAS TAKEN
