SHARP WARNING hard sent, took command, clear upper stretch, dug in late, held. FIRST CALL off bit slow, settled outside gain 2-3wide upper, closed fast. MANY AMBITIONS rated inside, well placed to 2nd turn, rail bid stretch, gamely. SUNRIS MISCHIEF settled 2nd flight, angled 3-4wide upper, mild late rally. KONA SKYE settled to backstretch, traffic 2nd turn, mild lat bid btwn foes. TEDDY'S TRIUMPH close up 3wide to backstretch, swung 4wide upper, weakened late. THOUGHTTHATCOUNT bobbled, broke out start, widest to 2nd turn, passed tired ones. CHASING RAIN pinched start, settled inside, gained upper stretch, flattened. CRIMSON LADY well placed inside, weakened far turn, passed tired foestretch. WESTERN GRIT broke in close up 4wide to backstretch, lost ground, empty drive. THE TRAINER OF FIRST CALL LODGED AN OBJECTION AGAINST SHARP WARNING, CLAIMING INTERFERENCE IN THE STRETCH. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED NO CHANGE WOULD BE MADE
