Weights: 118 lbs. Nominations Close Wednesday July 29th, 2026. Starters to be named through the entry box Saturday August 1st, 2026. A Trophy will be presented to the Winning Owner, Trainer, and Jockey. This stake will not split. In the event more than fourteen (14) horses pass the entry box at the time of closing of entries, preference will be given to those horses having accumulated the highest earnings as published by Equibase. Fees to be refunded to excluded horses.
