1 MILE 70 YARDS. (1.374) INDIANA FIRST LADY H. Purse \$150,000 (includes \$75,000ITDF – Indiana TB Development Fund) **FOR REGISTERED INDIANA BRED FILLIES, THREE YEARS OLD.** No nomination fee. \$150 to pass the entry box and an additional \$150 to start; with \$150,000 Guaranteed. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$1,000 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, purse to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. **WEIGHTS:** Wednesday, September 2, 2026. Starters to be named through the entry box by the usual time of closing. This race will be limited to twelve starters. If more than twelve horses pass the entry box, preference will be given to: (1) High Weights; (2) Highest Lifetime Earnings will be used in determining the order of preference of horses assigned equal weights (scale of weights considered). Entry fee only will be refunded if failure to draw into the race. Trophy to the winning owner. Management reserves the right to cancel this stake with less than six betting interests. Closed Friday, August 28, 2026 with 20 Nominations.

KABOOM was impeded at the start, rallied in the five path near the quarter pole and rallied strongly in the six path despite the rider standing up just before the wire. UNCLES LIL TROPHY dueled inside, was clear in the stretch and was caught late while coming out into a rival. SWEET SUMMERTIME saved ground, angled to the three path near the eighth pole, rallied and was steadied late between rivals. ELTINGE raced in the three path, was checked near the quarter pole to avoid a spill and improved late inside. SPIRITED JUSTICE stalked the pace between rivals and had no late bid. COUNTRY EMBRACE dueled outside of a foe, stepped out a lane near the quarter pole and was clipped, then faded in the stretch. PARTY IN THE CLUB bore out at the start, saved ground and checked near the quarter pole to avoid a spill. SWISS MERINGUE trailed and checked at the quarter pole to avoid a spill. GRAND HARBOR was herded out at the start, was steadied near the seven-eighths pole, stalked the pace inside, moved to the three path on the far turn, clipped heels when a foe stepped out and fell and was walked off. FOLLOWING A STEWARDS' INQUIRY, COUNTRY EMBRACE WAS DISQUALIFIED AND PLACED EIGHTH FOR INTERFERENCE TO GRAND HARBOR. THE RIDER OF SWEET SUMMERTIME LODGED AN OBJECTION AGAINST UNCLES LIL TROPHY NEAR THE WIRE. UNCLES LIL TROPHY WAS DISQUALIFIED AND PLACED THIRD.
