KENTUCKY BELLE bumped with an inner foe while prominent into the backstretch, pressed two wide, vied around the far turn, kicked away in upper stretch and drew off under a drive. BLESS HER bumped with an outer rival and bobbed in tight while prompting between horses into the backstretch, recovered to stalk close up along the inside, claimed place at the three sixteenths pole, vied with an outer pair for that position into the final furlong and held. TURNER'S CHARM settled two wide and between horses, tucked to save ground into the far turn, shifted three wide at the quarter pole, ran on to vie for place between rivals into the final furlong but was denied. BOHEMIAN trailed in the two to three path, advanced in the four to five path turning for home, sustained progress to bid for place in midstretch then flattened out. DAKOTAH BLUE steadied between horses soon after the start, hung in the five path around the first turn, stalked four to three wide, pursued within striking range around the far turn then faded between horses in upper stretch. CHARM OF VENICE (GB) steadied when keen behind foes leaving the first turn, laid off of the pace along the inside, tracked two wide and between horses around the far turn the gave way. TIME TO DREAM pursued three wide and between horses then tired. CALL ON ME set the pace along the inside as the eventual winner applied outer pressure, vied with that one around the far turn, proved no match in upper stretch and weakened. EMBRACE TIME chased four to five wide then was through turning for home. THE RIDER OF BLESS HER CLAIMED FOUL AGAINST KENTUCKY BELLE ALLEGING INTERFERENCE LEAVING THE FIRST TURN, BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
