Supplementary nominations may be made by the closing time of entries at a fee of \$2,000 which qualified to start with \$125,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: 122 lbs. Non-winners of \$50,000 since December 10, 2017 allowed 3 lbs.; \$40,000 since November 10, 2017 allowed 5 lbs.; \$25,000 since February 10, 2018 allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings, excluding money won in restricted races. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Friday, March 2, 2018 with 20 nominees.

WYNN TIME vied between foes early, angled four wide at the eighth pole and rallied. IVAN FALLUNOALOT vied in the four path, bid near the seven-sixteenths pole to be clear but couldn't last. OPERATION STEVIE raced inside, then had a mild late bid in the three path. WILBO stalked the pace in the four path, bid at the three-eighths pole, then faltered. WARRIOR'S CLUB was not a factor.
