1 1/8 MILES. (1.42) 11TH RUNNING OF THE WANDO. Purse \$100,000 ( plus \$20,000 State Bred ) FOR THREE-YEAR-OLDS. Nominations by 12:00 midnight Wednesday April 11 2018. \$1,000 due at time of final entry. Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made at the time of final entry by a non-refundable fee of \$2,000 which includes the entry fee. (Closed with 20 Nominations) The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight 123 lbs. Non-winners of a Sweepstakes of \$60,000 at a mile or over twice, allowed 3 lbs. Of a sweepstakes of \$60,000 at a mile or over once, 5 lbs. Of a race other than maiden or claiming at a mile or over, 7 lbs. (No Canadian Bred Allowance). Plus up to \$15,225 Ontario Sired/Ontario Bred Breeder Awards.

MACHTREE was bumped by TALE OF VIENNA at the start, settled at the back, raced two-wide on the clubhouse turn, unhurried down the backstretch, angled from two to four-wide at the 1/4 pole where he began to make up ground, rallied while lugging inwards down the stretch and drove past the leader past the 1/16th pole. INGE got out to set an unpressured pace, saved ground on the turns, never met the bid of another foe until he was run down past the 1/16th pole and held place. TALE OF VIENNA was bumped by TITOCHIP and forced into MACHTREE at the start, raced two-wide near the back on the opening turn, advanced into the middle down the backstretch, began his advance at the 3/8ths pole while racing three-wide, tracked the leader into the stretch, drifted outwards approaching the 1/8th pole before being herded inwards by MACHTREE in the late stages and just missed place. TITOCHIP broke outwards and bumped into TALE OF VIENNA, raced near the back, saved ground on the turns, commenced a rally in the stretch but was forced to steady as MACHTREE forced TALE OF VIENNA to close his path at the 1/16th pole. PIPERS WARRIOR stalked the leader early while racing on the inside, was in midpack down the backstretch, angled off of the rail entering the stretch, checked at the 1/8th pole as TALE OF VIENNA drifted out into his path and chased late. FLIGHT DECK stalked the pace while racing two-wide, commenced a bid midway around the far turn but never headed the pacesetter and faded in the stretch. THE RIDER OF PIPERS WARRIOR CLAIMED FOUL AGAINST TALE OF VIENNA AND MACHTREE ALLEGING INTERFERENCE IN THE STRETCH. THE CLAIM AGAINST TALE OF VIENNA WAS ALLOWED WHILE THE CLAIM AGAINST MACHTREE WAS NOT. HOWEVER, THE RIDERS OF TITOCHIP AND TALE OF VIENNA ALSO CLAIMED FOUL AGAINST MACHTREE, ALLEGING INTERFERENCE LATER IN THE STRETCH RUN, AND BOTH CLAIMS WERE ALLOWED.
