With all away in good order, RAGING BULL (FR) took up position in path two, sat reserved during the initial stages, was switched over to a brisk hand ride maneuvering into path three heading for the five-sixteenths pole, got set down for the drive home, shifted into path six from upper to midstretch for the optimal racing clearance, kicked into best with a sixteenth remaining, rallied with strong energy down the center of the course to steal away the decision in the last jump. MARAUD took the inside route until the end of the second bend, was set down to encouragement tipping to the outside stepping onto the head of the stretch, rallied partnered up with RIDE A COMET to his outside, beat that one to the punch to lead narrowly inside the sixteenth pole, dug in with determination attempting to stave off the top one in the final stages, got nailed at the wire. RIDE A COMET took up the chase from path two, drafting behind foes for a good portion of the journey leading up to the quarter pole, was under a drive coming three wide into the lane, hitched up to the winner as they closed in as a team on the one to catch, kept up his pursuit in earnest before weakening in the final seventy yards. GIDU (IRE) spurted away from the competition, got set up in path two, appeared keen, pulling on the left throwing the opening fractions, cut over to the rail at the top of the second bend, stepped into the lane, was called upon for more at the commencement of the run through the furlong grounds, was reeled in with about a sixteenth to and backed away. COMBATANT strung out three wide on both turns, got roused after going three-quarters, moved into path seven down the lane lacking a response. HAVE AT IT three wide on the first turn, was strung out in path four on the subsequent one, had no rally. WESTERLAND (GB) inside early, failed to menace. GUNNISON quickly over to the rail, came under a drive by the five-sixteenths pole, faltered. GEMONTEER loosely pocketed to the conclusion of the backstretch, chased the leader from path two during the run around the far turn, gave way.
