Weight: 122 lbs. Non-winners of \$60,000 twice at one mile or over, allowed 2 lbs.; \$60,000 once at one mile or over, 4 lbs. (Maiden and Claiming races not considered in estimating allowances). CHANNEL CAT tracked the pace under rating and to the outside of a rival, edged closer past the five eighths, went on the attack and overwhelmed the leader leaving the three eighths pole, moved clear and dropped in under an aggressive ride leaving the five sixteenths, kept on under stout handling past the furlong grounds and held firm. ADMISSION OFFICE settled well off the early pace, took closer order while under coaxing nearing the half mile marker, came off the inside with some momentum into the stretch, drifted out briefly near the three sixteenths, corrected to give willing pursuit but was simply no match for the winner. NAKAMURA, unhurried early while well off the inside, advanced four wide into the far turn, spun five wide into the stretch but one paced through the final furlong. NEEPAWA cleared early, set the early pace off the inside, dropped in towards the fence nearing the three quarter pole, failed to resist the winner's charge leaving the far turn, shifted out and pursued four wide into the lane, drifted in near the three sixteenths then steadied when in close, failed to recover and gave way. JAILHOUSE KITTEN saved ground off the early pace, angled out for the backstretch run, gained four wide leaving the far turn, failed to keep pace entering the lane and weakened. PEACE OF EKATI, four wide stalking the early pace, angled in past the three quarter pole, took closer order into the far turn, failed to quicken past the five sixteenths and faltered. QUEEN OF CONNAUGHT (GB), rank early on while saving some ground and stalking the pace, shifted out leaving the three quarter pole, failed to kick on under pressure past the five eighths and faltered. An objection by the rider of NEEPAWA against the winner for alleged interference around the final turn was not allowed. Also, an objection by the rider against ADMISSION OFFICE for alleged interference in upper stretch was not allowed.
