LIBERTY LOVER vied inside, was crowded and steadied late and lost position. TEXT ME ATTHE TURN vied between horses, was impeded and checked late and lost position. GATO DE RAYO stalked the pace while racing outside, bid six wide and lacked the needed late response. DANDY DAN was vanned off. Following a trainer's objection and a stewards' inquiry, WHOOP WHOOP was disqualified and place fourth for causing interference in late stretch.
