COMPLEXITY away in good order, quickly established control, was confidently ridden showing the way towards path two, was still on hold as the third fraction was being finalized, even with many pursuers now being called upon for much more themselves, scampered away to his largest lead when switched over to a drive in the vicinity of the three-sixteenths pole, appeared to switch back to the wrong lead, that is the left one, a few strides beyond the eighth pole, held sway. CODE OF HONOR brushed with SUCCESSFUL ZIP after stumbling badly at the break, moved over into path two by the conclusion of the backstretch, came under a ride for the drive home, angled out approximately five wide, was momentarily errant reacting to some stick work in midstretch, continued onward in a more professional manner afterwards and rallied for the place. CALL PAUL pursued the pacesetter three wide on the turn, was about as wide swinging into the stretch, proved no match for the top twosome. AURELIUS MAXIMUS hung out four wide at the top of the turn, got sent out into path six during the initial portion of the stretch, rallied mildly for the last major check. TROPHY CHASER took up the chase from the two path on the turn, commenced the stretch slightly wider, made no impact. ENDORSED rode the rail for the opening three-quarters pole, got set down prior to the quarter pole, angled out into path two stepping into the stretch, lacked the needed response. CASA CREED stumbled as the field was sent off and running, worked out a tuck into path three by midpoint on the backstretch, was maneuvered to the outside entering the stretch, went on to wander out into path seven all the while making no impact. LISTING leaned inward springing from the gate, making light contact with it, was three wide entering the turn and four wide exiting it, lacked the needed response. SUCCESSFUL ZIP brushed with CODE OF HONOR while shying away at the start, cut over to the rail, continued to take the inside route, stepped into the lane and had no rally. ACHILLES WARRIOR stalked the winner two to three wide, was put to a drive at the five-sixteenths pole, made it into the stretch and retreated.
