BATTLGROUND STAR drifted a bit into the first turn then stalked the pace about the four path, challenged toward the three eighths pole, took the edge approaching the five sixteenths, drew clear nearing the far turn, widened the advantage through the turn and held on well under steady encouragement. AMELIA BEDELIA stalked the early pace about the three path then moved to the rail midway on the opening turn, started a bid approaching the three eighths pole, rounded the far turn off the rail, couldn't improve significantly on the winner and settled for second. PARISIAN DIVA settled just off the early pace in the two and three paths then raced outside into the backstretch, bid approaching the three eighths pole, improved in the four path of the far turn, dueled for third mid-stretch and finished evenly. BUFFUM'S BELLE tossed her rider and ran loose in the post parade, was forced out a path into the first turn then settled off the pace about the four path, bid leaving the seven sixteenths pole, rounded the far turn in the three path but showed little further. FLATTER ME OWEN came away a step slow then saved ground into the first turn, moved to the outside entering the backstretch, rounded the far turn about the four path, left the turn widest and could only improve her position. SKYLAR'S TRICK checked off the heels of Amelia Bedelia at the rail midway on the opening turn and settled off the pace into the backstretch, showed little response through the backstretch and showed only a mild bid on the far turn. SHERWOOD LADY rated the early pace inside, was pressured nearing the three eighths pole, yielded the edge approaching the five sixteenths pole, dropped back into the far turn then faded at the rail through the turn.
