BUFF'S EYE VIEW steadied in the vicinity of the three quarter pole and rounded the opening turn in the four and five paths, raced outside into the backstretch, bid nearing the seven sixteenths pole, had aim in the three path midway through the far turn and dug in under determined handling to fend off the game effort of Opera Nite. Crowded in the vicinity of the three quarter pole, OPERA NITE stalked the pace from the inside, took the nod past the seven sixteenths pole, was pressured at the five sixteenths, dug in gamely with the advantage to late stretch but grudgingly ceded the final yards. MARTIN MAN rounded the opening turn about the four path and settled off the pace into the backstretch, bid approaching the seven sixteenths pole, raced at the rail rounding the far turn and finished evenly. OWEN'S MO angled in through the front stretch and rated the pace off the rail, was headed leaving the seven sixteenths pole, engaged in close chase from that point but dropped back midway on the far turn, angled to the four path leaving the turn and flattened stride. OWEN'S WAY saved ground well off the pace, bid leaving the seven sixteenths pole, rounded the far turn about the five path and showed little further. RUCKER was crowded at the rail in the vicinity of the three quarter pole, saved ground and showed little response. JAXBRADENRISHI stalked the pace three wide, picked up the chase toward the seven sixteenths pole, raced close through the backstretch then faded in the four path of the far turn. WONDER HOW raced off the early pace in the three and four paths then faded past the three eighths pole. The stewards reviewed claims of foul; the first was the rider of Rucker against the rider of Owen's Mo. As a result of that objection, the stewards disqualified Owen's Mo to sixth place for bearing in on the rider of Rucker in the vicinity of the three quarter pole, The second claim against the rider of Buff's Eye View, by the rider of Owen's Way, was not allowed.
