ESCAPE CLAUSE was in close quarters racing in front of the grandstand, moved into striking position, obtained the lead easily at the quarter pole, was given her cue into the stretch and drew off to a lengthy score in record time. RAIDER broke inward, reserved off the pace, chased hard but was no match for the winner through the stretch and held safely for place. SAIL ON BY quickly came in leaving the chute to secure a inside position, showed the way through the backstretch, was overtaken at the three eighths pole and weakened late stretch. ANSTRUM was forced to check racing in front of the grandstand, took closer order approaching the stretch and failed to threaten in the drive. BITTERS lacked a serious bid. SAVEITFORARAINYDAY was never involved. TRAINER OBJECTION- An objection lodged by the trainer of ANSTRUM against the rider of SAIL ON BY alleging interference racing in front of the grandstand the first time, after review of the stewards, SAIL ON BY was disqualified and placed fourth.\*\*TIMER MALFUNCTION- No time available for the three quarters fraction due to timer malfunction.
