BEACH FLOWER set the pace early, angled off the rail in the final turn, was under a long drive down the lane, came in twice and tightened up foe and prevailed in the final stages. VEXATIOUS stalked the pace early, shifted into the three path in the final turn, was under a long drive down the lane while three wide but did not have enough in the final stages. ENGLISH AFFAIR chased the pace early, was on the inside in the final turn, made a bid down the lane from the inside, was in tight inside the eighth pole then again late in the stretch, had to steady and gave in shortly after. RESIPSA was unhurried early on, angled off the rail in the final turn, made a bid down the lane but flattened out late in the drive. AMBOSELI trailed the field early on, shifted into the four path in the final turn, rallied in the stretch but leveled off late in the drive. SAVANNAH BELLE came out at the start, chased the pace early, shifted into the four path in the final turn and was empty down the lane. DARING DUCHESS tracked the pace early, shifted into the three path in the final turn and was faded late. SHEZAPRADO was bothered at the start and was no threat. VIVA VEGAS stalked the pace early, shifted into the three path in the final turn and was tired down the lane. THE RIDER OF ENGLISH AFFAIR CLAIMED AN OBJECTION AGAINST THE RIDER OF BEACH FLOWER FOR INTERFERENCE IN THE STRETCH RUN AND AFTER REVIEW BY THE STEWARDS, BEACH FLOWER WAS DISQUALIFIED AND PLACED THIRD FOR THE INFRACTION.
