

1 MILE. (Turf) (1.33) JUVENILE FILLIES TURF S. Purse \$75,000 FLORIDA-BRED FILLIES, TWO YEARS OLD. Free nomination by Sunday, October 28. \$750 to enter. \$75,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a stakes race allowed 2 lbs.; two races other than maiden, claiming, or starter, 4 lbs.; a race other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by usual time of closing. Supplemental nominations may be made at the time of entry. All fees shall be paid prior to the race. This race will be limited to 14 starters with also eligibles. Preference will be given to stakes winners, then by highest career earnings. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile).

VOW TO RECOVER slight step slow at start then allowed to settle out of gate, secured inside position in first turn, rated saving ground through backstretch, let out notch and advanced closer in far turn then shaken up for drive, picked up on cue and kicked by mid-stretch. DECORATED ACE was rated in range, hustled up three wide between rivals in far turn, set down for drive, came in path and brushed with rival at eighth pole, dug in determinedly and produced solid finish. MISS MARIU was reserved in back saving ground, driving racing wide upper stretch, finished with kick and gained late. LOVELY LUVY set the pace, dueled for lead at quarter pole, cut corner and took back control upper stretch, outkicked by winner mid-stretch then edged for show in final stride. BOX OF GOLD firmly rated in early stages, raced off top two leaders then hustled up between foes in final turn, continued bid into stretch, kept on then edged out for show. JOLIE BAY tracked the pacesetter, dueled for lead at quarter pole then gawey in stretch. SNOWZILLA raced off the pace, urged along inside and failed to reach threatening position. CLASSY LYNN rated midpack, roused four wide in final turn, failed to move on in stretch. BLAZING BROOKE raced five wide off pace in backstretch, hustled up in final turn then raced wide into stretch, failed to respond.
