MAJESTIC DUNHILL, bumped and pinched back at the break, settled well off the early pace, advanced to the outside of GOLDEN BROWN past the five sixteenths, swung out to about the eight path in upper stretch, closed determinedly under left handed rousing and forged to command late. SMOOTH B disputed the early pace four wide, eased back a bit nearing the half and stalked, came under firmer urging past the quarter pole, shifted out, closed gamely between rivals but wasn't quite good enough. OLDIES BUT GOODIES advanced to the inside of rivals and took command past the five eighths, set a solid pace towards the rail, was guided four wide soon into the lane, wandered outward past the eighth pole and gave way grudgingly. GOLDEN BROWN settled off the pace while saving some ground, eased out and advanced past the five sixteenths, angled seven wide moving with the winner into the lane, advanced between runners in mid stretch, altered in through the final sixteenth and kept on willingly. CORDMAKER was floated out at the break, settled off the pace, came under pressure three wide mid turn, moved up between runners in mid stretch then flattened out inside rivals late. SPARTICLE, between runners early, forced the pace three wide into the lane and faded. SHANE'S JEWEL led early between rivals, prompted the pace two wide around the turn, failed to kick on past the quarter pole and faded. RUGBYMAN, in the clear past the five eighths and in range of the leaders, was under a strong drive saving ground past the five sixteenths and came up empty. OLD TIME REVIVAL, hung out five wide stalking the leaders, failed to respond nearing the lane and gave way.
