MOBIL SOLUTION stalked the pace pressing to a short lead on the far turn, dueling inside of rival in close quarters a sixteenth out would cede grudgingly late. MOBIL AT LAST slow early was rushed to bid hard five wide on the far turn, lost momentum in upper stretch finishing evenly to gain a bit of position late. ROSCO P. COLTRANE stalked the pace chasing through the far turn into upper stretch weakening late on the inside. EIGHTTHEHARDWAY advanced to contention on the backside pressing through the far turn, wavered in upper stretch fading in the four path. GEPPEOTTO set the pace through the backside then gave way on the far turn. KALYDAR was always outrun.
