TRIGGER WARNING hustled out set a pressured pace through the turn, dueling in upper stretch angled out to take on BOBBY'S WICKED ONE as the pair exchanged bumps gamely keeping a nose down on the wire, was pulled up after the wire and along the turn with an apparent injury and was vanned off. BOBBY'S WICKED ONE pressured from the outset moving abreast TRIGGER WARNING through the turn to upper stretch, was tightened up when foe angled out as the pair exchanged bumps the final sixteenth missing on the wire. STILL HAVING FUN slow early lagged through the turn losing ground into upper stretch, responded inside the eighth pole closing steadily in the seven path. WYATT'S TOWN chased the pace through the turn coming three wide in upper stretch, angled out to mid track near the sixteenth pole hanging in the closing yards. COWBOY CREED hustled along chased the pace to upper stretch making no headway there with an even finish. MR ASHLEY pursued close up through the turn then faded in the six path upper stretch. MACHISMO saved ground to upper stretch proving no menace. WELLES CROWTHER played no factor. SMOKIN NITRO raced a step slow and bumped hard after the start along the inside. NAVY COMMANDER folded up on the turn. K CHOICE was always outrun. AN OBJECTION FROM THE RIDER OF BOBBY'S WICKED ONE AGAINST THE RIDER OF TRIGGER WARNING FOR INTERFERENCE DURING THE STRETCH RUN WAS DISMISSED BY THE STEWARDS.
