SUSANS VIOLETTE dueled inside FAST GATOR but off the fence, drifted out a bit leaving the turn and in the lane having secured the lead in upper stretch, held that rival at bay under steady urging. FAST GATOR moved up outside foes through the early stages to engage the aforementioned, dueled with that one drifting out a bit in tandem into the lane, could not get past but was second best. MCGLORIOUS settled off the inside, came into the stretch about five wide, shifted inside MONEY ORDER inside the furlong grounds, gained steadily to secure show honors. MONEY ORDER bumped the inside rival at the start, tracked in behind the dueling leaders, came in a bit entering the turn bothering rivals, shifted out five wide into the stretch and evened out. WEDDING DANCE bumped the outside rival at the break, chased in behind staying inside into the lane and had no late kick. PASSION TO WIN bobbed and was bumped at the break, close up inside but checked past the seven-sixteenths. COMICS CASHWAY bumped the outside rival at the start, was taken back when in tight between rivals early, settled racing off the inside and came into the stretch five to six wide. GONE SHOPPIN was sandwiched between runners at the break, forced to steady slightly when in tight between runners entering the turn, faded. FOLLOWING A STEWARDS' INQUIRY AS WELL AS OBJECTION BY THE RIDER OF PASSION TO WIN AGAINST MONEY ORDER ALLEGING INTERFERENCE ENTERING THE TURN, THE LATTER WAS DISQUALIFIED AND PLACED BEHIND THE FORMER.
