PARISIAN DIVA broke a step slow and was bumped by Grace Elizabeth, stalked the pace on the outside and took over past the five-sixteenths pole without encouragement, drew off through the turn in the three path, then drove down the upper stretch under moderate handling and finished with a hand ride. SKYLAR'S TRICK, saving ground into the first turn, settled off the pace inside, bid past the five-sixteenths pole, then started the far turn on the rail and eased out near the quarter pole to the five path, and finished evenly. FLATTER ME OWEN broke out and bumped Charitable Rose at the start and settled well back on the inside, eased out through the backstretch and bid near the five-sixteenths pole, took the turn in the five path, then gained down the lane on the outside and just lasted third. OCEAN LILLY settled off the pace inside, bid at the five-sixteenths pole and rounded the turn in the three path, and just missed third. GRACE ELIZABETH was bumped at the start by Thislillimeofmine and into Parisian Diva, settled off the pace outside, bid past the five-sixteenths pole and rounded the turn in the four path, then saved ground leaving the turn and leveled off on the rail. CHARITABLE ROSE was bumped at the start by Flatter Me Owen and settled well back on the outside; was never a factor. THISLILLIMEOFMINE broke in and bumped Grace Elizabeth at the start, then rushed up and angled in to rate the pace inside, then was caught past the five-sixteenths pole and was through.
