Eligibles must be registered with the Illinois Department of Agriculture as Illinois Conceived and Foaled or Illinois Foaled Thoroughbreds. By subscription of \$25 each horse made on or before November 25, 2017. (fee to accompany nomination.) To remain eligible the following payments must be made: \$100 each on or before April 5, 2018. \$250 each on or before September 6, 2018. If the \$25 nomination fee is not made in a timely manner, a late nomination fee of \$500 must accompany the \$100 April 5, 2018 payment. Nominees to pay \$250 each to pass the entry box, \$250 each additional to start. With \$50,000 Added from the Illinois Thoroughbred Breeders Fund and the appropriate purse account to be divided 60 percent to first; 20 percent to second; 11 percent to third; 6 percent to fourth; 3 percent to fifth. Weight; 121 lbs. Non-winners of \$25,000 at a mile or over allowed, 2 lbs.; at any distance, 4 lbs.; a race other than maiden claiming or starter, 6 lbs.; maidens, 8 lbs. Starters to be named through the entry box by the usual time of closing. Trophy to breeder and owner of the winner.

IRISH MARVEL angled inwards in the opening stages to take up a position just off the pacesetter stalking that rival under light reserve, continued to prompt the leader into the far turn, moved to wrest the advantage racing into upper stretch and went clear under firm right handed pressure. RONAN tracked off the second flight off the rail into the backstretch, was urged to advance three deep nearing upper stretch, couldn't gain terms with the winner but narrowly prevailed for the place honors. BOODA LOU angled to the rail in early stages while pulling a bit to track just off the pacesetter racing in close quarters to the backstretch, saved ground to upper stretch, came through inside foes in the lane while being urged to advance but couldn't match the winner and just missed for second. GET NONE sped to the fore while angling to the inside, dictated the pace to the far turn, briefly resisted the winner's bid through the second bend and gave out in upper stretch. BRILLIANT ONE switched off the inside tracking the leaders in last from out of striking distance to the far turn and offered no rally.
