The top three finishers in the Springboard Mile will get an automatic nomination to the Oklahoma Derby in 2019. The winner will receive an all fees paid entry into the Oklahoma Derby in 2019. A suitable award will be presented to the winning owner. Closed Wednesday, December 5th with (58) nominations.

LONG RANGE TODDY stalked the pace while two wide on the backstretch, rallied on the far turn then angled out to be four wide in upper stretch, was in a strong drive and held sway in the end. BANKIT was settled in the early going, rallied three wide and split rivals, angled out to be four wide and bumped in mid stretch then had clear running room and closed fast on the outside but was too late in the end. DUNPH stalked the pace while three wide on the backstretch, rallied on the far turn and gained the lead, was in a long drive but hung in late stretch. TONE BROKE was unhurried early then rallied six wide on the far turn, was gaining ground and closed willingly in the end. MARQUEE PRINCE vied for the lead while inside, was in a long drive then weakened in late stretch. EPIC DREAMER was settled while inside on the backstretch, made a bid and was four wide in upper stretch, was bumped in mid stretch and steadied then came up empty in late stretch. D TOZ was unhurried early then rallied six wide on the far turn making a bid then flattened out in the drive. KAZIRANGA was allowed to settle then saved ground on the far turn then was inside in the stretch and was no menace. DOBBINS G vied for the lead while two wide on the backstretch, was in a long drive then faltered in late stretch. TOBACCO ROAD was unhurried early then rallied five wide on the far turn making a bid then was no menace. SIX SHOOTER was allowed to settle then rallied four wide on the far turn, was bumped in mid stretch and came up empty in the end. A claim of foul was lodged by the trained of EPIC DREAMER against the rider of BANKIT for interference in mid stretch. After reviewing the film's, no action was taken.
