STORMY MUSIC got away well while veering out at the start, was allowed to settle and raced in the back, offered a mild bid only and failed to menace. MAGDALENA'S MOMENT vied inside to the upper stretch and gave way. RENTS OVER DUE vied two across to the turn and stopped. The stewards' posted an inquiry concerning possible interference in the stretch. No change was made.
