SIX SHOOTER restrained early while racing in the second flight and saving ground, eased out and moved a bit closer between horses and in some traffic late backstretch, continued to stalk the leaders into the stretch, dropped back to the inside under clever handling when straightened for home, slipped through along the rail to challenge a sixteenth out, proved best under brisk handling late. NINTH STREET lacked early foot while being carried out four wide into the first turn, made a good advance three wide into contention in the final turn, lost some ground to the winner into the lane, outkicked by that one late while up for the place. MR MONEY BAGS settled off the pace and the inside, stalked the pace midway up the backstretch, moved to the fore into the far turn, showed the way into the lane, allowed the winner the inside nearing the sixteenth mile marker, could not match that rival in the run to the wire, caught in the waning strides for the place. VOO DOO DOC within striking distance while along the inside, in traffic, steadied when lacking room a quarter out, fell back a bit and then went evenly to the wire after recovering. STUPIFY pressured the early leader from the outside in the first turn, brief bid between rivals far turn, weakened in the drive. B W P EXPRESS broke in good order, set the pace for over a half along the inside, began to give way when confronted in the far turn. TRUMPS REVENGE got out into the first turn, raced back and as never a serious threat. TROY OUNCE last away, carried out five wide in the first turn, was also never a factor.
