HARVEY WALLBANGER settled nicely out of the gate and secured inside position in the first turn, continued unhurried saving ground through the backstretch, patiently ridden then let out notch at three eighths pole, gained closer contention then cut the corner entering top stretch, given cue under right handed drive, kicked in with strong response, powered forward to the lead and held firm. EVERFAST raced in contention being rated just off the early leaders, settled nicely awaiting cue then commenced steady two wide bid through final turn, continued bid racing in tandem with HARVEY WAHLBANGER entering top stretch, moved up closer then shifted out four to five wide with furlong left to run, kept on with good response and got up in time for second best. MAXIMUS MISCHIEF raced in tracking position behind the pacesetter in the first turn, continued to track EPIC DREAMER racing three paths off inside through the backstretch, tapped on shoulder going by half mile marker, shook the reins to gain closer contention on leader in final turn, raced near equal terms and dueled at furlong marker then got outkicked by late gainers. EPIC DREAMER broke to the lead and led the way in the first turn, continued to set the pace to final turn, came under pressure from MAXIMUS MISCHIEF but held off rival's bid in final turn, could not hold off rival upper stretch, dueled for the lead at the eighth pole then lacked kick in reserve and gawey. MIHOS raced off the top two leaders going through the first turn, continued in range racing two wide between foes at half mile marker, flattened out in final turn then kept on evenly in the lane. GARTER AND TIE was briefly fractious in the gate, unhurried in early stages racing near the back, hustled up along inside in final turn then switched out three wide upper stretch and failed to move on. FEDERAL CASE moved head at break then hopped and slightly bobbled step out of the gate, rated through early stages, raced four deep going by the half mile marker, failed to sustain bid through final turn and dropped back. COME ON GERRY raced in range, hustled up racing three wide between rivals in flight off top pair near the half mile marker then came up empty in final turn. GLADIATOR KING was reluctant to load, raced off the pace then faltered.
