SPOOKY CHANNEL raced close to the pace while in traffic, bid five wide leaving the turn, closed steadily and got up in the final strides. GATO GUAPO set a pressured pace, responded when challenged to duel past the eighth pole, inched away for a short lead, came out late under left handed urging and was caught near the wire. CLEANUP HITTER was never far back, saved ground, shifted out on the turn, bid three wide, closed willingly, was squeezed between horses late and checked. STRATTON saved ground, stalked the pace while being rated, challenged along the rail into the turn, dueled to the eighth pole and was unable to sustain his bid. RATE FOR ME advanced to the second turn, bid six wide, closed well but didn't have enough late. THE TRAILER GUY was unhurried early, trailed the field, offered a mild bid inside and failed to menace. KITTEN'S ROYAL raced in the back, bid eight wide and did not threaten. CONSUMERCONFIDENCE pressed the pace while racing outside, tired on the turn and gave way. THE GLORY IS ALL MINE pressed the pace to the second turn and stopped. The rider of CLEANUP HITTER lodged an objection against the riders' of GATO GUAPO and SPOOKY CHANNEL for alleged interference near the wire. No change was made.
