RATED R SUPERSTAR was unrushed in the three path, rallied four wide at the three-eighths pole, vied outside foes in the stretch and prevailed under strong urging. SNAPPER SINCLAIR stalked the pace in the three path, bid at the three-eighths pole, vied between foes and was outfinished. GIANT EXPECTATIONS was off awkwardly, stalked the pace in the four path, bid at the three-eighths pole, vied between foes and was outfinished. NANOOSH pressed the pace in the two path, bid at the three-eighths pole, vied inside and was no match late. CHRIS AND DAVE pressed the early pace between foes, settled in the two path, bid at the three-eighths pole and closed late. HEAVY ROLLER was unrushed, bid at the five-eighths pole, then had a mild late bid. SONNETEER raced inside, then lacked a late bid while three wide in the stretch. HENCE had a mild stretch bid. DALMORE led inside to the far turn and faded.
