SUNSCREEN was unhurried early, circled seven wide through the second turn, was gaining into the stretch, took control late stretch and surged clear for the win. QUITE PEACE raced in mid pack early, advanced six wide into the second turn, made a bid at the three sixteenths pole, couldn't hold off the winner and finished second best. DOM RIGHT pressed the early pace, raced between rivals into the home turn, took a brief lead in early stretch and weakened in late stretch. DAUX set a pressured early pace, raced along the inside throughout, me the bid of QUITE PEACE, dueled briefly and faded. CATCH TEN was allowed to settle early, saved ground into the home turn, checked off heels through the turn and flattened out. BASHFUL BOB was void of any early speed, went three wide into the second turn and never fired. SANDIA'S BEAT stalked the early pace, fought the rider and tired. DUE TO A TIMER MALFUNCTION THE RACE WAS HAND TIMED.
