VIC'S PICK chased the pace toward the inside, angled three wide through the turn, dueled to the lead inside the sixteenth pole and held on well. BEST SHOT chased the pace from the three path, took the lead two deep leaving the quarter pole, dueled with the edge through the turn but picked up the challenge of Vic's Pick mid-stretch, reluctantly ceded to that one then held on for second. BURNIN RING O FIRE chased the early pace outside, raced off the rail rounding the turn, eased slightly out mid-stretch and was gaining on Best Shot. CAYENNE CREEK gave chase inside, rounded the turn in the four path and finished evenly. BLUSHING OWEN was hustled to a clear lead and set the pace, gave up the nod past the quarter pole, dueled at a close disadvantage nearest the rail rounding the turn then faded in the stretch. BOUNDTOBEGOOD chased the pace while angling in, raced at the rail on the turn and showed little more. BOOTSIE BOY gave chase in the four and five paths and showed little more. TRUE CROSSING was not a factor.
