

7 FURLONGS. (1.22³) ROBERT HILTON MEMORIAL S. Purse \$100,000 FOR THREE YEAR OLDS. Free nominations close Saturday, April 6, 2019. \$500 to enter with a purse of \$100,000 Guaranteed. Supplemental nominations of \$1,000 will be accepted by the time of closing of entries, all fees included. Horses having won a North American, European or Asian graded or group stake will have \$500 of their entry or supplemental fee refunded upon starting. Entries close Wednesday, April 17, 2019 by the usual time of closing. After payment of 1% to the owners of all horses finishing seventh thru last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Weight: 123 lbs. Non-winners of a sweepstakes in 2019 allowed 3 lbs.; non-winners of \$26,000 in 2019 allowed 5 lbs. Field will be limited to ten starters with up to four alternates. Preference to North American, European and Asian graded or group stakes winners in order (Grade 1, then Grade 2, then Grade 3), then to highest earnings in top 6 placings inn North American, European and Asian graded or group stakes, then to highest lifetime earnings. Trophy to the winning owner, trainer and jockey.

MALPAIS rated a short lead inside, was pressured leaving the three eighths pole, increased his advantage through the far turn then steadily handled down the lane. ADMIRAL LYNCH settled off the pace in the three and four paths, raced outside into the backstretch, bid leaving the three eighths pole, rounded the far turn in the five path and dueled the final sixteenth for second. FEDERAL CASE rated close inside, bid leaving the three eighths pole, raced at the rail on the far turn then outfinished in the later duel for second. WAR TOCSIN stalked the pace from the two and three paths, challenged leaving the three eighths pole, stayed in range of the lead off the rail on the far turn but flattened stride through the stretch. ZULU LEGEND rounded the opening turn in the four path and settled outside into the backstretch, bid toward the seven sixteenths pole then faded in the four path of the far turn. PADRINO'S HEART showed little response through the backstretch. POOL BOY CHARLIE raced well back.
