SUCCESSFUL SAINT was unhurried along the two path, angled out, responded when asked and rallied for the score while going away at the end. TROPICAL JOY vied for the lead three across, responded when roused and finished well. JEB vied for the lead from between on the turn, shook clear some and weakened. PRINCESS DREAM was well placed, gained along the two path into the lane, appeared in tight nearing the eighth pole, took up and weakened. DR RUTHLESS hopped at the start, three path into the turn, four wide out of it and hung. JO JO hopped at the start, saved ground and failed to threaten. ANGRY PATTY vied for the lead along the rail and gave way. COLIN'S GO GO saved ground, was outrun. A Stewards inquiry was posted concerning the stretch run, resulted in the disqualification of JEB from third to fourth for interference with PRINCESS DREAM around the eighth pole.
