1 MILE. (Turf) (1.332) SAN FRANCISCO MILE S. Grade III. Purse \$250,000 (plus \$1,500 Other Sources) FOR THREE YEAR OLDS AND UPWARD. By subscription of \$50 each to accompany the nomination or by supplementary nomination of \$2,000 at the time of entry which includes all fees. \$2,000 to enter with \$250,000 Guaranteed. Weights: Three-Year-Olds, 116 lbs. ; Older, 122 lbs. This event will be limited to fourteen (14) starters (7 North American starters and 7 Non-North American starters). Preference will be given in the following order: (1st) Grade/Group I winners in 2019; (2nd) Grade/Group II winners in 2019; (3rd) Grade/Group III winners in 2019. (Total earnings in 2018-2019 will be used in determining the order of preference of horses with equal Grade/Group wins.) For horses that have not won a Grade/Group race in 2019, preference will be total lifetime earnings. A trophy will be presented to the winning owner. Closed Thursday April 18, 2019 with 34 nominations.

BLITZKRIEG stalked the leader to the second turn, pushed up two wide to take the lead at the quarter pole, pushed clear to mid stretch but was all out to hold. RIVER BOYNE (IRE) settled mid pack to the half, got fanned four wide on the second turn then closed ground steadily but too late. CHOO CHOO was chasing to the second turn, raced three wide to the stretch, got outkicked to mid stretch but kept to task to the line. LE KEN (ARG) was settled to the half, raced two wide to the stretch then could not impact the top three. GRECIAN FIRE was chasing for a half mile, raced three wide to the stretch then finished evenly in the final furlong. BOWIES HERO had no speed, trailed to the second turn, saved ground then shifted out into the stretch and closed some ground late. WENTWOOD (GB) had no speed, settled to the second turn, was two wide to the stretch but lacked a closing response. MANY ROSES hustled to the front, set the pace to the second turn then was overtaken and tired in the drive. SOUTER (GB) had no speed, got fanned five wide on the second turn then jumped the tracks into the stretch, bobbled and gave way. MITHQAAL was settled to the half, raced three then four wide on the second turn, also jumped the tracks into the stretch and stopped.
