Supplementary nominations may be made by the closing time of entries at a fee of \$3,000 which qualifies to start with \$150,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among all other starters. Weights: 122 lbs. Non-winners of \$40,000 twice allowed 3 lbs.; \$35,000 at any time allowed 5 lbs. (Maiden and Claiming races not considered in allowances.) In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings excluding money won in restricted races. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Thursday, April 18, 2019 with 24 nominees.**

NITROUS was settled in hand while angling to the rail dropping well off the leaders in the opening quarter, gathered momentum switching off the inside nearing upper stretch, swung out five wide in upper stretch and produced a sustained response to reel in LANDESKOG and go clear in time under strong handling. The latter broke sharply to establish a narrow advantage along the rail, dictated the pace racing into the turn, shook clear racing into upper stretch to open a commanding advantage but couldn't fend off the winner. GRAY ATTEMPT, in touch with the first flight four wide between foes in the opening stages, was urged to advance in that path into the lane but lacked the needed late kick while continuing with some interest to prevail for a share. NINTH STREET settled last racing to the turn, angled out five wide in upper stretch and made some late progress to gain position between foes. BANO SOLO, in touch with the pacesetter prompting that foe between rivals racing into the turn, continued in pursuit to upper stretch and faded leaving midstretch. CLASSY JOHN vied with the first flight three wide between foes while caught in close quarters nearing the turn, angled to the inside midway through the bend and soon faded. FROSTED ICE settled outside foes tracking the leaders from well out of striking distance, advanced in tandem with the eventual winner while being fanned six wide racing into upper stretch but lacked the needed final response. OIL MONEY was urged to terms with the first flight racing five wide through the backstretch, continued in pursuit of the pacesetter four wide on the turn to upper stretch and gave way.
